

### Governors' Written Statement of Behaviour Principles

#### Rationale and Purpose

This Statement has been drawn up in accordance with the Education and Inspections Act 2006, and DfE guidance (Behaviour and discipline in schools: Guidance for governing bodies). The purpose of this statement is to provide guidance for the Head Teacher in drawing up the Behaviour Policy at English Martyrs' Catholic Primary School so that it reflects the shared aspirations and beliefs of governors, staff and parents for the children in the school, as well as taking full account of law and guidance on behaviour matters. The policy aims to underpin the governor's duty of care to all pupils and employees, promoting teaching and learning and high standards of attainment and excellent progress. It is intended to help all school staff to be aware of and understand the extent of their powers in respect of discipline and sanctions and how to use them. Staff should be confident that they have the governor's support when following the school's Behaviour Policy.

This is a statement of principles, not practice it is the responsibility of the Head Teacher to draw up the Behaviour Policy at English Martyrs' Catholic Primary School, though she must take account of these principles when formulating this.

The Head Teacher is also asked to take account of the guidance in the DfE publication Behaviour and discipline in schools: Advice for Head Teacher's and school staff (January 2016).

The Behaviour Policy must be publicised, in writing, to staff, parents/ carers and children each year. It must also appear on the school's website

### **Principles**

We the Governing Body of English Martyrs' Catholic Primary School believe that Every child has the right to learn and achieve their full potential in a safe, secure and orderly environment.

- Everyone has a right to be listened to, to be valued, to feel and be safe. Everyone must be protected from disruption or abuse.
- English Martyrs' Catholic Primary School is an inclusive school; all members of the school community should be free from discrimination, harassment, victimisation and any other conduct that is prohibited by or under the Equality Act 2010.
- All adults staff, volunteers, governors and parents will set excellent examples to the children at all times.
- Every child will be given a sense of personal responsibility for his/her own actions.
- The school's Behaviour Policy will ensure that there are measures to encourage good behaviour, self discipline and respect, and prevent all forms of bullying amongst pupils; it must also provide guidance on the use of reasonable force and other physical contact.
- Where there are significant concerns over a pupil's behaviour, the school will work with parents to strive for common strategies between home and school.
- The school will seek advice and support from appropriate outside agencies where concerns arise over a child's behaviour.
- The school's Behaviour Policy will clearly reflect the school's approach to exclusions.
- The school's Behaviour Policy will set out the disciplinary action that will be taken against pupils who are found to have made malicious accusations against school staff and the pastoral care available to staff accused of misconduct.
- The school's Behaviour Policy will explain the circumstances in which screening and searching may take place.
- The school's Policy will clearly outline the extent to which staff may discipline children for behaviours that take place beyond the school gate and outside school hours.
- The school's Behaviour Policy will set out the expectations of parental behaviour on site an in close proximity to school.
- The school will fulfil its legal duties under the Equality Act 2010 in respect of safeguarding, children with special educational needs and all vulnerable children.
- The school will keep abreast of current issues and initiatives with regard to Health and Safety at Work Act 1974 and relates regulations.

Governors will monitor the behaviour of pupils through the termly Head Teacher's Report to Governor's. Governor's will support and challenge the Head Teacher in order to promote good behaviour.
